IMPORTANT NOTICE OF IN-PERSON VOTING CLOSURES

This IMPORTANT NOTICE is included to inform you that in-person voting options for the City of Santa Ana Special Recall Election have been CLOSED in response to the COVID-19 pandemic.

According to California Governor Newsom's recent Executive Order (N-48-20), the generalized use of in-person voting may present risks to public health and safety in light of COVID-19 and could risk undermining social distancing measures imposed by the State Public Health Officer.

The City of Santa Ana Special Recall Election will take place as a mail-ballot only election. Ballots will be mailed to all voters on April 20, 2020 – you have the following options to return your ballot:

- Mail your ballot (pre-paid postage) on or before May 19, 2020
- Drop off your ballot at the Registrar of Voters' ballot drop box no later than 8 p.m. on May 19, 2020, 1300 South Grand Avenue, Santa Ana
- Drop off your ballot at other ballot drop box locations in the City of Santa Ana no later than 8 p.m. on May 19, 2020 (for locations visit ocvote.com/dropbox or call 714-567-7600)
- If you did not receive a ballot by April 27, 2020 visit ocvote.com/replacement or call 714-567-7600

Voters with disabilities, or those with medical impacts due to COVID-19, can download an electronic ballot to their computer and mark it using their own assistive technology and then print. Voters should follow the return instructions included with the electronic ballot. To request a Remote Accessible Vote-by-Mail ballot voters can:

- Call the Registrar of Voters at 714-567-7600
- Requests must be received no later than May 12, 2020 at 11:59 p.m.
- Voters with disabilities, or particularized needs, who are unable to download or cast an electronic ballot, should call the Registrar of Voters at 714-567-7600 no later than May 15, 2020 to discuss options for casting a ballot in this election.

Can I vote if I register after the registration deadline?

Yes, conditional voter registration extends the 15-day registration deadline in California to eligible voters, allowing them to register and vote provisionally starting 14 days prior to an election and on Election Day.

Can I vote if I moved to another address in Orange County?

Yes, but you must register at your new address by the deadline above.

Can I vote if I have not voted in the last 4 years?

RESIDENCE CONFIRMATION:

If you have not voted in any election within the preceding four years, and your residence address, name, or party preference was not updated during that time, you need to confirm your residence address in order to remain on the active voter list and receive election materials in the mail.

Vote-by-Mail

You can vote by mail before Election Day

Every voter in the City of Santa Ana will receive a Vote-by-Mail ballot. You can mark the ballot and send it back by mail or drop it off at any ballot drop box listed in this guide. Vote-by-Mail ballots must be postmarked or delivered to a ballot drop box by **May 19, 2020**.

Remote Accessible Vote-by-Mail Ballot

The Remote Accessible Vote-by-Mail ballot provides voters with disabilities, those with medical impacts due to COVID-19, and overseas voters the option to request a vote-by-mail ballot to be delivered electronically. The electronic ballot can be downloaded to the voter's computer, marked using the voter's own assistive technology and then printed. Follow the return instructions included with the electronic ballot.

To request your Remote Accessible Vote-by-Mail ballot you can:

- Complete the postcard with pre-paid postage located on the back of this guide
- Visit ocvote.com/myballot
- Call the Registrar of Voters at 714-567-7600
- Email myballot@rov.ocgov.com

No later than seven days before Election Day, the voter may request the county elections official to send or deliver a ballot that voters with disabilities can read and mark privately and independently pursuant to the federal Help America Vote Act of 2002 (52 U.S.C. Sec. 20901 et seq.).

How to return your Vote-by-Mail ballot

Mark your ballot, then follow the instructions on the official envelope to sign and seal your ballot in the postage-paid envelope provided.

You can:

- Mail your ballot, so that it is postmarked by Election Day, May 19, 2020

Language Voter Assistance

State law required language assistance information

No later than seven days before the day of the election, the voter may request the county elections official to send a Vote-by-Mail ballot in Spanish, Vietnamese, Chinese or Korean, or a translated reference ballot in Tagalog or Farsi (Persian) for eliqible precincts.

City of Santa Ana Special Recall Election Information

There are two questions on the City of Santa Ana Special Recall Election ballot:

- The recall question asking if the current City Council Member should be recalled
- The contest to select a new City Council Member if the current City Council Member is recalled

A "**Yes**" vote on the recall question means the voter wants the incumbent City Council Member recalled (removed) from office.

A "No" vote on the recall question means that the voter wants the current City Council Member to remain in office.

The second question on the ballot considers those candidates who are campaigning to replace the incumbent City Council Member if she is recalled. A voter may vote for one of those candidates who are listed on the ballot or may write in the name of a qualified write-in candidate.

You do not need to cast a vote for each section. You may cast a vote for either section or both.

If more voters mark "YES" than "NO" on the recall question, the current City Council Member will be removed from office. If more voters mark "NO" than "YES", the current City Council Member will remain in office.

If the current City Council Member is recalled, the candidate who receives the most votes will be elected as the new City Council Member. That person can be sworn in as the City Council Member once the results of the election are certified.

2020 CENSUS: WHAT YOU NEED CENSUS TO KNOW

The Census is a count of every person living in the U.S. every 10 years. The count is mandated by Article 1, Section 2, of the U.S. Constitution to ensure residents in every state receive fair representation and resources.

Why is the 2020 Census important?

- It's about making sure every voice in your community is counted
- It's about resources for your community (schools, free lunch programs, college grants, housing vouchers and more)
- It's about fair representation in local, state and federal government

How is the Census data used?

- By law, U.S. Census data cannot be shared with immigration or law enforcement agencies
- By law, U.S. Census data cannot be used to determine eligibility for government benefits
- Census data is used to advocate for more resources for community members
- Census data is used to inform public safety, and the building of new schools and hospitals
- Census data is used to decide where to open companies and businesses, which creates jobs

STATEMENT OF REASONS FOR THE PROPOSED RECALL OF CECILIA IGLESIAS

The grounds for the recall are as follows:

Ms. Iglesias' Republican Party-driven agenda led her to vote against affordable housing while the residents of the City of Santa Ana are suffering from a housing crisis.

Ms. Iglesias doesn't condemn President Trump's cruel deportation policy towards immigrants, many of who are part of the Santa Ana Latino and Vietnamese communities.

Ms. Iglesias supports President Trump's policies of separating children and families at the border and building a wall that will cause division without improving border security.

Ms. Iglesias posted a video advocating for the complete "DEFUNDING" of the Santa Ana Police Department.

Ms. Iglesias opposed revenue initiatives supporting after-school programs, infrastructure, homeless services, and public safety.

Ms. Iglesias fails to see the need for homeless shelter beds in order to legally and humanely enforce the "No Camping" ordinance that would make our communities safer.

Ms. Iglesias advocated for CHARTER SCHOOLS as a SAUSD Trustee.

As a Council Member she continues supporting charter schools that will lead to a loss of local school revenue of \$10 million.

Ms. Iglesias voted "NO" for the \$400 thousand payout to the former city manager but then voted "YES" on the new city manager's contract including a possible \$500 thousand payout.
